PCHD News Release COVID-19 Cases Numbers Declining in Pike County, IL

Pike County, IL – Cases of COVID-19 in Pike County, IL continue to decline. Pike County Health Department (PCHD) was notified of 41 positive cases of COVID-19 so far in the month of October 2021. Of those, 4 cases (9%) were fully vaccinated. There are 2 Pike County residents hospitalized. The average age of those who have tested positive for COVID-19 so far in the month of October continues to decrease and is 26 years old. Currently 40.9% of eligible Pike County residents are vaccinated.

PCHD continues to offer COVID-19 vaccinations with Pfizer, Moderna, and Johnson and Johnson's Janssen vaccine every Thursday in October from 1:30 to 4:30 pm at the health department. No appointment is necessary, but masks are required to enter the building. Watch for signs to help with parking and entering the building.

Pfizer vaccinations are available to those age 12 and above, Moderna vaccine is available to those age 18 and above, and the Janssen vaccine is available to those age 18 and above. PCHD is also offering Pfizer booster shots to those over the age of 65 or to those with underlying health conditions 6 months after their 2nd vaccination.

Pfizer and Moderna 3rd shots are available to the following:

- Those receiving active cancer treatment for tumors or cancers of the blood
- Those who have received an organ transplant and are taking medicine to suppress the immune system
- Those who have received a stem cell transplant within the last 2 years or are taking medicine to suppress the immune system
- Those with moderate or severe primary immunodeficiency (such as DiGeorge syndrome, Wiskott-Aldrich syndrome)
- Those with advanced or untreated HIV infection
- Those who are actively being treated with high-dose corticosteroids or other drugs that may suppress your immune response.

The Centers for Disease Control and Prevention (CDC) recommends urgent action to increase Coronavirus Disease 2019 (COVID-19) vaccination among people who are pregnant, recently pregnant (including those who are lactating), who are trying to become pregnant now, or who might become pregnant in the future. CDC strongly recommends COVID-19 vaccination either before or during pregnancy because the benefits of vaccination outweigh known or potential risks.

If in question, please talk to your healthcare provider about your medical condition, and whether getting an additional dose is appropriate for you.
